

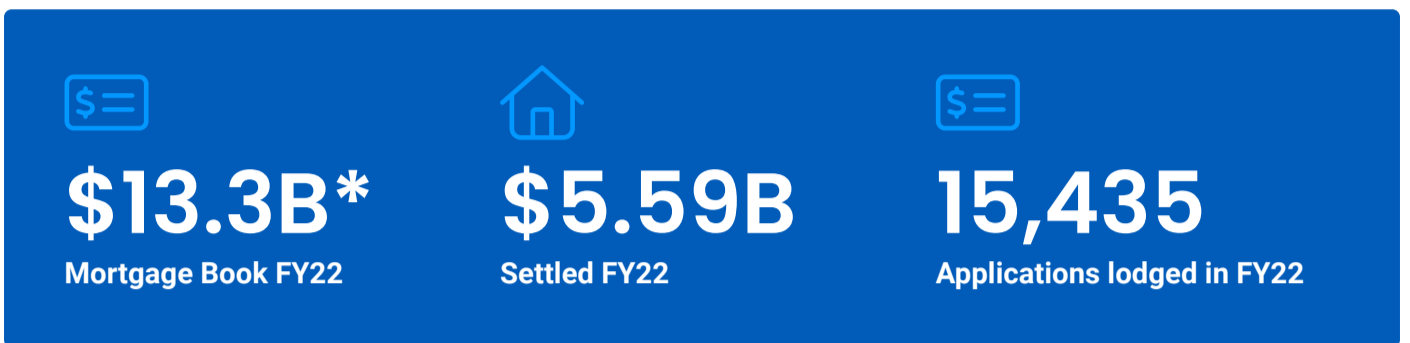

Employing **48 staff** including a dedicated sales and partnership team, we provide you with one-to-one support and direct access to our AFG Home Loans credit assessment team.



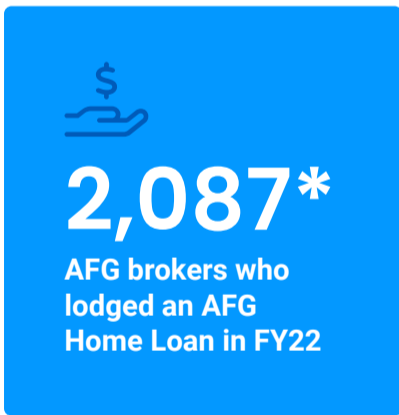

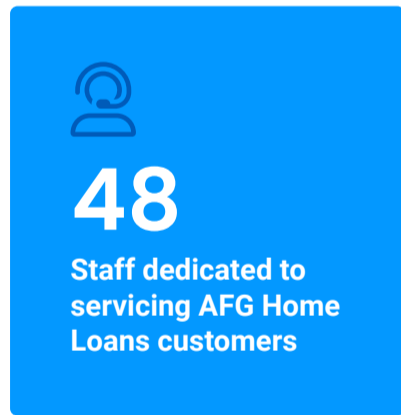
